## ET20/71 Minutes:

The minutes of the meeting of the Environment & Town Committee dated 1 February 2021 were amended to remove the unnecessary "to" within the response to planning application 20/01130/FUL, the Chair stuck out the word and initialled the amendment within the minutes which were then confirmed as a correct record.

## ET20/72 Wirksworth Rainbow Day

Proposal from a community group to start a new event each February commencing 2022 to celebrate diversity.

RECOMM: That the Town Council support the principle of the event and will fly rainbow flags at the Town Hall (in the same manner that flags are flown for Festival, Armistice day etc.)

#### ET20/73 Action Against Racism

Proposal from a resident to join/follow the High Peak Borough Council's initiative "Stand up to Racism" (Wirksworth sits within Derbyshire Dales District Council region)

RECOMM: That the council welcomes this wider initiative, but given the short timescales and current Covid restrictions the Mayor should issue a press statement encouraging people to support the campaign and attend the online events (Cllr Taylor to provide details). The council to

consider more active participation in 2022 including flying flags (if these are available).

## ET20/74 Fanny Shaw Skate Park

New Opportunities Wirksworth have asked if the Town Council would apply for planning permission for the new skate park to demonstrate the council's commitment and support for the initiative – no additional financial support is sought at this time.

RECOMM: That the Council demonstrate its support for the project by submitting (ino WTC) the application (prepared by the group).

#### ET20/75 Snow Warden Scheme – Wash Green / School

An informal request has been received from the school about the Town Council's possible participation in the Snow Warden scheme.

RECOMM: That the Town Clerk contact Wirksworth Community Response Group and BIG to ensure they are aware of the snow warden and to enable them to assess whether it is appropriate to use their local groups of volunteers to participate in the snow warden scheme and clear snow within their respective areas.

#### ET20/76 Meadows

To agree an interim management plan for the space. The plan to be applied pending the broader public consultation on future use of the space which has been paused due to Covid.

RECOMM: That the Town Clerk prepare a proposed timetable of the stages and potential dates to restart the consultation. In the interim the paths across the meadows are to be kept clear, including cutting a wide band adjacent to the path to allow people to safely pass (in line with Covid recommendations).

## ET20/77 20's Plenty Campaign

A Derbyshire group is seeking the Council's support for a policy of "20's Plenty for Derbyshire".

RECOMM: That the council support the campaign.

#### ET20/78 Oak Sapling Planting Enquiry

Enquiry from a resident of Duffield regarding possibility of planting saplings on council land.

RECOMM: That the provenance of the saplings be established to ensure they are native. That the council take up the kind offer from Cllr Barker to take some saplings (up to 100), which will be planted on Cllr Barker's land as a tree nursery with the future intention that the saplings be used by local groups. Cllr Stockell, Cllr Pollock and Cllr Taylor to help with any groundwork /planting.
