ET20/25 Minutes:

The minutes of the meeting of the Environment & Town Committee dated 07 September 2020 were confirmed as a correct record.

ET20/26 Tiny Forest

Rotary have contacted the Town Council to explore if there is any land (in the ownership of the council) within Wirksworth which might be used to create a tiny forest. (Item withdrawn)

To consider acquiring the land at the rear of Griggs Gardens from DDDC to plant a tiny forest (Proposal from Climate Change Group).

RECOMM: That the matter be placed on hold pending further update/request from Rotary.

ET20/27 Severn Trent land at Wash Green

Severn Trent estates have approached Derbyshire Wildlife Trust regarding the management of woodland near to Wash Green.

RECOMM: The matter be referred to committee in November to allow Cllr Pollock to report back (following meeting with DWT and STW).

ET20/28 Sunday Remembrance Service

The town council has advised the secretary of the local British Legion branch that the parade is to be cancelled this year. Instead, wreath laying will occur as part of the service within the church (if services are allowed by C19 regulations in force at the time). No response has been received from the local branch and a communication needs to be prepared to ensure the public are aware of this decision.

RECOMM: The Clerk prepare a message (from Mayor) to be posted on Facebook and website to inform public of the Town Council's position.

ET20/29 Street Lamp Poppy Campaign

To consider whether to participate in this scheme in 2020 – DCC Highways require compliance with specific rules on installation including notification of each lamp post/ street furniture where it is proposed that a poppy be mounted. (In 2019 poppies were installed at the entrance to the Town Hall and on the Gates adjacent to the Memorial Hall).

RECOMM: That poppies be installed at Town Hall entrance and at the gate adjacent to the War Memorial.

ET20/30 Litter and Dog Fouling Campaign

Dales District Council have launched a campaign urging residents to report areas in the district where litter and dog fouling are causing a problem under a new campaign – 'Don't be a tosser – bin it!'. They have offered support to groups and individuals who want to help reduce the problem in their community by providing biodegradable pink chalk-based spray paint to highlight dog mess and put up signs.

RECOMM: The Town Council participate in the campaign, with staff using the chalk marker to highlight any dog fouling on WTC property (e.g. Stoney Wood, Meadows, Wash Green Play Area). That the Clerk contact DDDC and request a supply of the signs linked to the campaign.

ET20/31 StarDisc / Stoney Wood

Advice received from DCC Highways who have recommended the installation of 'K Barriers' which would prevent motorcycles from accessing the site whilst still allowing push chairs/wheelchairs – there is an option for the barrier to be combined with a gate. Signage has been created outlining the new site restrictions.

RECOMM: That the new signage be erected at the entrance to the StarDisc, that the wider issue of ASB and StarDisc be referred to Full Council for further discussion.

ET20/32 Reopening High Streets Safely Fund – Derbyshire Dales

Funding is available for the implementation of measure (linked to C19) within town centre. Any expenditure must meet strict criteria and must be spent by 31 March 2021, DDDC/DCC are seeking input from Town Council on potential local initiatives.

RECOMM: The matter be referred to full council for further discussion.

ET20/33 The Peaks and Dales Railway Reinstatement Proposals
