C20/103 Confirm the accuracy of the Minutes of the Meeting of the Wirksworth Town Council held on 16 November 2020

RESOLVED that the minutes of the meeting of Wirksworth Town Council dated 16 November 2020 were confirmed as a correct record.

C20/104 Town Mayor's Announcements Socially distanced light switch on of the Rotary Christmas Tree (no public present), planted the 1st tree in a Tiny Forest project at Bolehill.

C20/105 Accounts Paid - November 2020

RESOLVED that payment of the attached account in the sum of $\pm 13,725.24$ be approved.

C20/106 Minutes and recommendations of the Finance, Buildings & Personnel Committee:

RESOLVED That the minutes and recommendations of the Finance, Buildings & Personnel Committee dated 7 December 2020 be approved.

C20/107 External Audit

RESOLVED to note that external auditor confirmed that there were no matters giving cause for concern and that the comments (in other matters) regarding Internal Audit be raised with the internal auditor during 2020/21 audit process.

C20/108 Budget and Precept for 2021/22

To agree the proposed budget and precept for the next financial year – recommendation from FB&P that no increase be made to current precepting level.

RESOLVED that given the impact of restrictions on the Town Council's ability to raise funds for activities such as occasional lettings of its buildings, in order to achieve a balanced budget, many non-essential services and activities have either be placed on hold or curtailed during 2021/22. This has enabled the council to hold the precept at the same level at previous year £194,000 as the council recognises that the impact on Covid will continue to be felt by many residents (and their finances) during the coming year.

C20/109 Wirksworth and District Community Sports Group Response

Request for financial support for new initiative.

RESOLVED that the Clerk write to the group advising the council has set aside a small general donation fund in the 2021/22 budget and invite an application for funds from this. That the council also consider/discuss in 2021 whether it is appropriate that a specific amount be allocated to supporting the sports group each year, similar to the support given to the Arts (Festival) / Well Dressing/Carnival (for inclusion in the 22/23 budget).

C20/110 Delegated Powers

The Clerk reminded councillors that delegation was established both to deal with any urgent matter related to hire of rooms and the broader ability to deal with urgent matters

> RESOLVED that the council confirm that the powers established (Resolution C20/46) regarding decisions on reopening of buildings and other matters related to C19 continue (delegated to Cllr Gratton, Cllr Barker and Cllr Stockell), delegation on other urgent matters remains as Mayor, Deputy Mayor and 2 committee Chairs.

C20/111 Community Choir request to sing at Tuesday Market

A request has been received for 10 members of the group to attend and sing at the last market before Christmas on 22/12/20. (referred as an appeal by applicant under C19 procedures – FBP20/10)

RESOLVED that the Clerk advise the group that the Council do not feel that it is the appropriate time or indeed location for carolling during the Tuesday Market. We have continued to operate the market throughout the 2nd lockdown and in the current designation of Tier 3 with significant staff resources dedicated to crowd management in the limited space surrounding the Memorial Hall. Whilst the atmosphere created from the carols would no doubt be pleasant, the council has chosen not to play Christmas music (as we have in past years) as we have been actively trying to ensure a steady flow of customers through the market and discourage lingering, the presence of Carollers would undermine this.

C20/112 Public Space Protection Orders

The District Council's current Public Space Protection Orders (PSPOs) are due to expire 31st October 2021. They cover dog control, alcohol consumption, fires & BBQs, driving & parking. For any renewal, or proposed new location (e.g. Meadows), Wirksworth Town Council needs to provide evidence to be able to demonstrate the need to introduce/retain the PSPO in the current areas.

RESOLVED that the Clerk advise that existing PSPO be retained and that a request be made for an order to be made regarding dog fouling on the Meadows. The Clerk to liaise with DDDC regarding the retention/implementation of the orders.

C20/113 Derbyshire 52 Weeks Festival (Cllr Taylor)
