2. support initiatives on a case by case basis. Such initiatives could include the installation of solar panels, undertaking planting on council owned property, the installation of electric car charging points on council property;

3. meet regularly so as to give the council timely advice.

b. Support the establishment of an independent group with council representation to mitigate climate emergency issues which concern the town as a whole.
