C21/61 Minutes of the meeting of the Wirksworth Town Council 15 November 2021:

RESOLVED that the minutes of the meeting of Wirksworth Town Council dated 15 November 2021 were confirmed as a correct record.

Cllr McDonagh reported that she had met with 3 candidates and a further 3 meetings were scheduled in the new year\*. (\*these meetings were in response to the offer to all interested parties to meet a councillor and clerk to understand the role better prior to standing for co-option – Resolution C21/64)

C21/63 To receive the recommendations contained in Notes from Working Parties

Environment & Town dated 6 December 2021 Finance, Buildings & Personnel dated 13 December 2021

RESOLVED to adopt the recommendations of the Environment and Town Working Party dated 6 December 2021 and Finance, Buildings & Personnel Working Party dated 13 December 2021.

#### C21/64 Accounts Paid

November 2021 in the sums £14,760.73

RESOLVED that payment of the attached account in the sums of £14,760.73 be approved.

### C21/65 Concessionary Lets in 2022/23

To consider approval of a concessionary let to the Festival of (upto) 10 days at a value of £4500 and Carnival of (upto) 3 days at a value of £1500.

RESOLVED that as this has been agreed in past years that the concessionary lets be approved.

## C21/66 Process for meetings in 2022

The council resolved to review it use of working parties in place of committees (the change was undertaken in order to enable all councillors to participate in discussion regarding council issues.) Updated guidance also appears to allow for councillors to participate in discussion during a hybrid meeting, but only councillors <u>present in person</u> may vote.

Cllr Casselden and Cllr Foster-Phillips apologies were accepted on 20 September 2021, and therefore will need to attend a meeting on or before 19<sup>th</sup> March 2022 (or their apologies must be accepted by council at the full council meeting on 21<sup>st</sup> February 2022, as full council on 21<sup>st</sup> March is after the statutory 6 month period)

RESOLVED that that given the recent emergence of the Omicron variant of Covid, that the council adopt a process of hybrid meetings for full council (from February) to allow all councillors to participate in discussion and that the council retain working parties in place of committees. The arrangements should be reviewed again in March 2022.

### C21/67 Process for Co-option

In the event that there are 3 or more candidates, there is a possibility that during the ballot process a majority vote is not achieved and that remaining candidates are tied. To proceed further, the council must either vote a candidate out of the selection process or vote to retain a candidate in the selection process before resuming process to establish a majority vote for a single candidate.

RESOLVED that in the event that this scenario should occur (tied vote, no majority), the council will vote to remove a candidate from the process, the voting process will then restart in order to establish a majority vote for a single candidate.

#### C21/68 Transfer of Church Walk

To review the proposed transfer agreement proposed by DDDC to allow the asset transfer of the space on Church walk from DDDC to WTC. At present, if a Bin Store was to be installed and if this required planning permission it might be deemed to trigger the overage clause.
