## C20/58 Accessibility Statement

### C20/59 Covid -19 Discretionary Grant Application

During recess in August, the Town Clerk made a submission to the scheme administered by Derbyshire Dales District Council on behalf of the Town Council (prior to closure of the fund). The revenue for the Town Council is anticipated to be reduced by 60% for this financial year.

RESOLVED That the Clerk's actions be ratified and that the Town Council accept the grant of £10,000.

### C20/60 Emergency Budget

To consider amendments required to the budget to ensure continuity of services through to March 2021.

RESOLVED That once 6 months of financial information is available (at end of September) that all existing budget amounts be reviewed and that work begin on proposed budget for 2020/21.

### C20/61 Councillor Email

The existing solution is not reliable, with many councillors unable to access their .gov.uk emails. The current working practices place an increased reliance on digital working and therefore an alternative solution has been sought. The email account provision can be

moved to the same solution used for WTC office email (which will also provide IT support) at a cost of £72 per councillor (Total £792).

RESOLVED That the Clerk make arrangements to transition to the new email solution.

## C20/62 Climate Emergency Working Group (Attached)

Report from the group including two specific recommendations:

- -To seek to reconvene the Community Climate Change Group with WTC Cllr representation and to offer concessionary meeting space (once this is permitted).
- -To seek to acquire Griggs Gardens as a WTC asset with the view to tree planting.

RESOLVED That the matter be referred to Environment and Town Committee meeting for further discussion.
