C22/167 Non-Compliant Hirers – Farmer Market

Under Delegated Powers, the officers manage bookings (to ensure staffing and compliance with H&S etc..) but clarification/guidance is

being sought on the appropriate course of action when a hirer fails to provide sufficient and/or timely information in support of their bookings.

In November, documentation was requested in support of the Farmers Market Booking (evidence of Insurance, Market Plan, Risk Assessment). To date only a risk assessment has been received. The Council has sought to clarify the documentation required when using the outdoor space with new terms and conditions effective from April 2023, requiring that documentation should be submitted at least 1 month before a booking. In January, advance notice was given of these proposed changes to the Farmers Market operator including clarifying the documentation required.

This matter was discussed at length given the importance and prominence of this event within the town with options considered that included cancellation of the booking, operation of the event by the Town Council.

RESOLVED that in the absence of a policy to deal with the implications of the cancellation of a major event due to noncompliance with the Council's booking policies/documentation, that the council seek confirmation in writing that NOW accept full liability for the event and on this basis the council will extend the deadline for the documentation until (latest) June. The matter may then be reconsidered once the new council has taken office. That in the meantime, a meeting with NOW be arranged to urgently obtain the missing documentation (delegating representation to Cllr Whittall, Cllr Barker, Cllr Carr, Cllr Pollock and the Clerk – min of 2 Cllrs to attend).
