8. Safer Roads Group (attached)

To consider what support might be given to the recently established community group which has the initial objectives:-

- to improve road safety in Wirksworth
- to improve health through noise and emissions reduction
- to enhance accessibility of footpaths to facilitate school routes, walking, pushchairs, bikes, wheelchairs etc.

DCC have issued an initial consultation to change the speed limits to 30mph on B5023 (Cromford Road,

Harrison Drive, St Johns Street, Warmbrook and Derby Road). The deadline for comment would not allow ratification at full council and therefore the matter was dealt with using delegated powers (WTC made a request for this change in 2019). The following a response was made "The proposal accords with the Town Council's past request for action and no amendments are requested at this stage of the process therefore Wirksworth Town Council welcomes this proposal and raises no objection."
