Amongst the concerns flagged up by the the insurer was a concern over Building Maintenance with an issue identified within the atrium – the skylights are leaking and frames are showing signs of deterioration (FB&P have requested that the matter be referred to Full Council given the potential significant costs of works to this part of the building).
