C23/115 Co-option Process – Vacant Seat

To consider how to fill the vacant seat on Wirksworth Ward should DDDC Electoral Services confirm that a casual vacancy exists and can therefore be filled by co-option.

RESOLVED that the vacancy be filled by co-option at the next full council meeting on 19th February 2024. The vacancy to be advertised, candidates asked to provide an expression of interest including a brief statement (no more than 300 words) addressing the question "What can you bring to the Town Council if you were co-opted as a councillor?" by 12/2/24 (to allow statement to be included in the agenda pack). The Clerk to contact those candidates that were unsuccessful at the last co-option in 2023 to advise them of the new vacancy. All other elements of the co-option process remain the same as before.

C23/116 Meadows Funding Application

An expression of Interest has been made to the DDDC administered Derbyshire Dales UK Shared Prosperity Fund & Rural England Prosperity Fund Call for Capital Projects: Improvements to Town Centres

RESOLVED that the decision to submit an expression of interest ("Eol") be ratified. That should the Eol be successful (this should be known by 5/2/24), the application be prepared to move to the next stage of the process (deadline 23/2/24). It is acknowledged that the timescales and requirements/conditions of this grant funding stream present risks to the Town Council including potential reliance on meeting any shortfall/contingency from reserves. Therefore notwithstanding the decision to move forward with the application, the council reserves the right to review or withdraw their application at any stage should it feel that (financial) risks posed by proceeding with the application outweigh the potential offered by this funding stream.

C23/117 Review of Christmas Arrangements

In 2022, the Town Council took over arrangements for the supply and decoration of Christmas Tree on the Market Place car park from Wirksworth Rotary Club. At the same time, the Council also took on the Festive Light Switch-on as well as starting a Sunday Christmas Market. In 2023, the Sunday Market was arranged by the Town Council as part a wider Christmas themed weekend sharing some of the logistics and marketing with the Farmer's Market. Due to adverse weather, the Sunday Market in Wirksworth was cancelled (alongside other nearby markets such as Belper).

RESOLVED that in 2024 the opportunity to operate a Christmas themed weekend market be passed to the Farmer's Market (i.e. the Town Council will no longer operate a separate market on the Sunday after Farmers Market in December). That the Town Council continue to arrange the Saturday Lights Switch On, however that Town Councillors will be expected to attend the event to assist with marshalling. The presence of councillors will provide much needed

additional stewards and emphasise that this event is now operated and provided by the Town Council.
