To support local celebrations, Derbyshire Dales District Council is providing "one-off" grants to town and parish councils: £500 for town councils £250 for parish councils

These grants aim to assist with events like street parties, lunches, beacon lightings, fetes, cultural performances, and permanent commemorations. The Town and Parish Council can use the grant to support a single event or a series of events at their discretion. The relevant town and parish council can also allocate the funding in whole or part, to support the activities of other local groups who may be planning an event, provided the event is clearly linked to VE Day or VJ Day commemorations.
