The Town Council endeavours to**  facilitate communication and cooperation between community groups, the Railway did not approach the TC regarding bunting in the Town.

## ET25/19 Rock House For Sale

Cllr Whittall would like the TC to contact Tarmac, the owners of Rock House, asking them to consider a hotel development on this site. **REC Council do not have a policy on specifying or influencing** which properties could become commercial. However, encourages all Cllr's to express any personal opinions to the property owner directly.

#### ET25/20 Memorial Stone request

The RBL have requested permission to erect a memorial stone in the Memorial Garden in front of the soldier silhouette. **REC the TC does not object to the installation of a memorial of this size however, they must be consulted on the final design and stipulate that the memorial can not be dedicated to any one person.**
